## Nashua City Council Meeting Welcome Center August 7, 2017 at 7 p.m.

The Nashua City Council met in regular session August 7, 2017 at Nashua City Hall at 7:02pm. Mayor Angelina Dietz presided with Council members Rolland Cagley, Brenda Roberts, Tom Johnson, Ryan Jung and Kyle Lane were present.

The following employees were in attendance: City Attorney David Skilton, Sergeant Travis Marvin, and Water Superintendent Jeff Smith. 50 guests were in attendance.

Motion by Roberts, seconded by Cagley to approve the agenda. Motion carried unanimously. Motion Lane, seconded by Cagley to approve bills for August 7, 2017-attached in a separate file. Motion carried unanimously. M/S/C

## **Department Reports:**

City Attorney Skilton: Drafting ordinance for fireworks. Called for inspection of 220 Main St. to check stability of structure. Litterer building – waited for plan to reinforce the building and haven't received it. Scoles building is ready for disposition as the title is clear. Alton property is waiting for response, but doesn't expect one. Tyler Tech sent 77 pages for the accounting procedures.

Police Sergeant Marvin: The City does have an ordinance on grass clippings and on burning. Contact police if you have these situations. Phone is 435-2068 or cell: 641.220.4445.

Water Superintendent Smith: 109 Panama St was repaired for the water line.

Mayor Dietz thanked Nashua Fire Department, all responding fire departments, Nashua Police Department & Sheriff's Office for their help at the GMT fire. Reminder August 12<sup>th</sup> is the beach party at the Cedar View Park.

Councilman Johnson: The Fire Dept. will attempt to burn down the old elevator again on Saturday. They plan on being there for the water ball fight for kids at Beach Party.

Councilman Jung: thank all the businesses for donating to the Beach Party event.

Discussion/ approval of bill for Cronin, Skilton & Skilton was held. Skilton had sent a letter on 8/3/2017 detailing his bill. He felt, with the current finances, that the City could pay \$2725 right now and then more of the bill in the future. Jung made a motion to pay the \$2725 amount, Roberts seconded. M/S/C

Discussion held on petition to the City Council. Larry Johnson read the petition He said they are not close to 24/7 coverage, highway seems to have most coverage, 90-year-old fell & no one responded. Ben Scholl said none of the options listed were viable. Stephen Johnson said some calls haven't been received for non-emergency events. Marty Hemann said there is an app on phone & call goes to Sheriff's Department. Doug Strike wanted to have law enforcement stay and maintain at least 3 FT & 3 PT police officers. Diane Reuscher stated there is no crime because we have the police here. Annie Krull asked why the police is the first to be cut, she likes the safety they provide. A small committee was formed to discuss the budget for police. Those members were: Marty Hemann, Doug Strike, Travis Marvin, Larry Johnson and Mayor Dietz.

Discussion held on Cash Transactions Report. Council reviewed the numbers.

Discussion held on Revenue and Expenditure Reports. Council reviewed the revenue report first. No concerns. Reviewed expenditure report. No concerns.

Discussion/ approval of TIF payment for Cedar Hill Development. Nancy Demro spoke about wanting to build a new road between Bonzers and Groens as well as wanting to get the TIF money. Skilton thought we should get an opinion from John Danos about it. Tabled until the next meeting.

Discussion/ action regarding closure of a city road. The Park Board had requested the road to the park, between Charles City Road entrance and the tennis courts road be closed Aug. 12<sup>th</sup> from 9 a.m. to 6 p.m. for a "Beach Party" event. Lane made a motion for the street closure on Aug. 12 from 9 a.m. – 6 p.m., Johnson seconded. M/S/C

Discussion/approval for Casey's General Store expansion. Larger map of the expansion area was reviewed. One concern was water run-off. Jeff Smith said he would talk with the DNR.

Roberts left the meeting at 8 p.m.
